## Elizabeth Township Farmland Preservation

The Elizabeth Township Trustees have resolved, at their January 5, 2011 meeting to again commit \$1,000,000.00 for the purpose of preserving prime agricultural

soils by sponsoring their Farmland Preservation Program. This year we have three options that landowners can use to preserve their land if they so desire. We have the local Township program, the Ohio Agricultural Easement Preservation Program, and the USDA Farm and Ranchland Protection Program to use. The Township will use both the USDA-FRPP and the Ohio AEPP to rank the applications to prioritize the funding if there are more farms that apply than there are funds available.

We have four landowners in the Township who applied for the 2010 USDA-NRCS Farm and Ranchland Protection Program consisting of a total of 654.37 acres. This program had \$2.1 million in funds that were committed to farmland preservation in Ohio and our farms have all been accepted into this program. USDA-NRCS contributes 50% of the easement value, Elizabeth Township contributes 25% of the easement value, and the land owners donate the final portion of the value of the preservation easement. The deadline for the applications was June 16, 2010 and we expect that the landowners will receive their funding by the summer of 2011. Since that time NRCS has added over seven million dollars more to the available preservation funds for Ohio.

The Township Trustees have also committed the balance of the unused funds from 2009 and 2010 toward the preservation program in 2011 giving us a total of approximately 2.3 million dollars that are allocated for the purchase of conservation easements. To date there have been preserved about 660 acres through the Ohio Agricultural Easement Protection Program, 680 acres through the USDA-FRPP program, and 640 acres through the local township program.

We know that there will be another FRPP program in 2011 with sign up dates of February 28, April 29, and June 30, 2011. During the December 31, 2010 sign up period we had seven more landowners apply to the FRPP which represent 1397 more acres of township land. ## **Elizabeth Township Historical Museum**
