ITEM # 1 The board and Chris Bobb discussed junk cars issues. Chris Bobb said the law used to be complicated, but the state has made it easier now. The sheriff's department will try and work with someone before citing them for junk vehicles on their property.

Dilts was made to hire Rebekah Eidemiller for Saturdays at a rate of \$8.50 per hour and After Hours as needed at \$15.00 per hour. VOTE: Mr. Sutherly-yes, Mr. Dilts-yes, Mr. Ryman-yes. John R. Ryman, President, declared the Motion carried.

Mr. Sutherly had no new business.

Mr. Dilts said he has spoken to Mr. Havenar and Mr. Baker at the county engineer's office and they agree with Mr. Dilts that Shaggy Bark needs repaired. Mr. Dilts said he spoke with Bob from Wagner Paving and he suggests milling everything and using two-inch asphalt, which is better than what the county offers. Mill Road and Weddle Road will need chip and sealed in the next year or two. Mr. Dilts will contact the engineer's office to see if they will prepare the bid package for Shaggy Bark, along with the specs for the project. Mr. Dilts said he has not received any quotes on the milling work. The board discussed keeping the milling debris and using it in other areas. Mr. Sutherly said he thinks the county will police the project to make sure it is being done according to the specs.

Mr. Ryman said we still need someone to mow the ditches. The rate per hour was passed at \$14.00 per hour, but we may need to go up to \$15.00. Mr. Ryman said he would call Dan Miller about mowing.

ITEM # 11 With no other business to be transacted a Motion by John R. Ryman; Seconded by Greg D. Dilts was made to adjourn. The meeting adjourned at 7:38 p.m.
