**ITEM #1** There was no new business to discuss.

**ITEM #2** Mr. Marchal/Mr. Blackmore- Mr. Blackmore reported he's been prepping for the Eclipse. Asked what the status was on painting at the EMS/Fire building. It's been several months and the maintenance men haven't started yet. Mr. Mott to obtain some quotes for having the painting done. Mr. Dilts said it would be a good idea to implement the Maintenance Request Form at the EMS/Fire building.

Mr. Marchal shared the March EMS/Fire Report. There were 8 EMS, 3 MVA, 2 Fire, 1 Water Rescue. 9 calls in the township, 5 mutual aid calls, 3 to Tipp City, 1 to Casstown, 1 to Lostcreek Township. There have been 31 calls to date for 2024.

Would like to hire 5-7 part-time employees, there has been a down turn in the availability of employees. Ended employment with one employee that was no longer showing up and not responding to communication attempts.

Mr. Dilts to contact the county prosecutor's office to gather more information on the threshold of employees. The request was tabled, until more information is gathered. Mr. Dilts noted the Miami County Prosecutor's Office will be drafting a letter to the City of New Carlisle, regarding the missing radio for reimbursement.

#### ELIZABETH TOWNSHIP MEETING MINUTES OF APRIL 3, 2024 CONTINUED:

The board discussed the fact the township is responding to Casstown out of contract. Mr. Blackmore will contact the village financial officer with an offer for services. If the request is rejected it goes no-where. If the offer is accepted, more details of the contract will follow.

At the meeting on March 20, 2024 the board voted to no longer supply coffee and filters. A Motion by John R. Ryman, Seconded by Greg D. Dilts to rescind that portion of the Motion and will supply coffee and filters for the EMS/Fire building. VOTE: Mr. Ryman-yes, Mr. Dilts-yes, Mr. Mottyes. Randy Mott, President, declared the Motion carried.

**ITEM #3** ETCC- Mr. Rice-Absent-No report available.

**ITEM # 4** Bills submitted for payment totaled \$129,650.95. A Motion by Greg D. Dilts, Seconded by John R. Ryman to approve the payment of bills for \$129,650.95 as presented. VOTE: Mr. Ryman-yes, Mr. Dilts-yes, Mr. Mott-yes. Randy Mott, President, declared the Motion carried.

**ITEM # 5** Mr. Cozatt-Barn permit was issued at 3277 Gearhart Road. The Adams Road porch is getting cleaned up. 1555 Dayton Brandt Road has a total of 18 vehicles on the property. The property is grown up and 17 vehicles are out back in the weeds. Mr. Cozatt will be notifying the property owner regarding property cleanup.

Mr. Dilts wanted it noted that <u>**RESOLUTION NUMBER 2017-002**</u> is in place prohibiting the location of medical marijuana cultivators, processors and retail dispensaries licensed under Ohio revised code chapter 3796 within the unincorporated territory of Elizabeth Township, Miami County, Ohio and <u>**RESOLUTION NUMBER 2024-001**</u> is in place to prohibit adult-use Cannabis operators from operating within the unincorporated area of Elizabeth Township, Miami County, Ohio.

**ITEM # 6** Meeting Minutes of the Regular Meeting on March 20, 2024 were approved as presented.

**ITEM #7** Various financial reports were shared with the board. Mary Ann asked board approval to Amend, Close and File the final ARPA Fund project and expenditure report with the U.S. Dept. of Treasury, once the March ARPA interest is posted. A Motion by John R. Ryman, Seconded by Greg D. Dilts to allow Mary Ann to Amend the ARPA fund reflecting the accumulated 2024 interest paid to the fund, pay Imagine Networks the March Interest for final payment, and file the Final Project and Expenditure Report with the U.S. Department of Treasury. VOTE: Mr. Ryman-yes, Mr. Dilts-yes, Mr. Mott-yes. Randy Mott, President, declared the Motion carried.
