ITEM # 1A There was no new business to discuss.

Mary Ann noted the Miami County Auditor's website has property tax increases posted for all parcels in Elizabeth Township should the 8-mill levy pass. To locate your property tax increase, go to the Miami County Auditor's website, and enter your address. The dollar amount of the increase will be posted for your parcel.

Mr. Mott said he and Mr. Ryman met with the rep from OTARMA. It was suggested to increase the value of the engine to \$550,000.00 from \$330,000.00.
