ITEM # 1A There was no new business to discuss.

ITEM #1B Josh Luthman from Imagine Networks reported that the fiber route as detailed in the Memorandum of Understanding dated April 20, 2022 is completed. All known locations and residents in Elizabeth Township, Miami County have high speed broadband available to them. The neighborhoods surrounding Shaggy Bark Road and Mill Road were not built with fiber, due to already existing wired internet service and little to no interest from the residents. Imagine will build fiber to these areas if there is sufficient interest. The board was in agreeance to the submitted information by Josh Luthman. The board noted that Imagine Network will be paid at the next meeting on April 5, 2024, for the remaining funds and interest from the ARPA Fund. It was noted that if someone is interested in fiber broadband from Imagine Networks you can request by calling them, texting them, email, or go to Inexfiber.com to sign up.

VOTE: Mr. Ryman-yes, Mr. Dilts-yes, Mr. Mott-yes. Randy Mott, President, declared the Motion carried.

Nic noted he will be out of town March 26, - April 2, 2024.

ITEM # 5 Bills submitted for payment totaled \$46,209.62 A Motion by Greg D. Dilts, Seconded by John R. Ryman to approve the payment of bills for \$46,209.62 as presented. VOTE: Mr. Ryman-yes, Mr. Dilts-yes, Mr. Mott-yes. Randy Mott, President, declared the Motion carried.

ITEM # 6 Mr. Cozatt-Permit for a room addition in Shaggy Bark was submitted. A vacant building in Alcony is in deplorable condition and needs to come down. Mr. Cozatt to check on any historical value before pursuing further.

Mr. Mott-The Historical Society will be purchasing gates for Mann and Hart cemeteries. Township maintenance men will install the gates. Mr. Mott will gather more information on installation costs/details and report back to the board.

Dump truck is clean and at the EMS/Fire bay. The mowers and tractors are being serviced to get ready for the spring and summer season.

Mr. Ryman-Drains at EMS/Fire building were checked by Alexander's. It appears that a non-operating sump pump may have been causing the problem. The 2 bathroom drains may be due to the 3 compartment septic tank needing pumped. Drains will be rechecked after the tank is pumped.

Would like to have the For Rent sign put out at the EMS/Fire building for room rental.

Mr. Dilts-Durst Brothers are finishing a couple of projects and should be able to begin our project by mid-May. Would like to have Mill Road paved this year, due to timing issues with the Sander's Road project not being completed in time for paving. Sander's Road could be paved next year.

A complaint was received that more gravel needs down on the South Side of the alley on Alcony Conover. Mr. Dilts will look into the matter. No new information on the missing radios.

ITEM # 10 Laura Sutherly discussed what to expect in the next blast. Public comments were heard regarding EMS/Fire, Eclipse, fiber right of way repairs.
