The month of December, 2006, there were a total of 11 Medic runs and 2 Fire runs. The total number of runs for the 2006 was 136 runs. There were 3 responses for motor vehicle crashes. The EMS responded to illnesses and injuries resulting from household accidents. The average response time was 7 minutes from the time of dispatch to the time on the scene.

## Sheriff's Beat

Elizabeth Township entered into a contract for 1 year, 2007. at a cost of \$93,189.47 for the total base salary of a regular Deputy for the term of this agreement. Elizabeth Township will reimburse the County for all fuel and service. This service is 7 days a week, 8 hours at day as assigned by the Sheriff. The County agrees to pay for all fringe benefits of the Deputy when assigned to this area.

## A Brief History of the Township Churches

There are three churches in the township. Alcony Grace, Cove Springs, and McKendree United Methodist. They have been part of this township for many years.

Alcony Grace was built in 1881 at 1045 S. Alcony Conover Rd. Missionary work has been something the church has been involved in from the earliest times.
