## Farmland Preservation

Farmland Preservation is alive and well in Elizabeth Township! We did not have any applicants rank in the Ohio Agriculture Easement Preservation Program high enough to receive funding this year, although residents who are interested in any of the programs for farmland preservation need to apply to this program as the first step in order to

receive a ranking that is used to determine the eligibility for both the local Elizabeth Township Farmland Preservation Program and the new USDA Farm and Ranchland Preservation Program. The Elizabeth Township Trustees applied for and received over \$400,000.00 from the USDA-NRCS to be used for the purpose of preserving farmland in our township. Two months after we received that grant, we were informed that another \$200,000.00 was also available. We have two farms that have applied for the federal program and are starting the application which includes a detailed appraisal. The whole process takes about 18 to 20 months, but in the end, 49% of the easement value is paid for by the federal program and 25% of the easement value is paid for by Elizabeth Township and the landowner donates the rest, which can be a tax benefit to the owner. If you have 40 acres or more of agricultural land and are interested in preserving your acreage from future development, please contact any of the Trustees or Randy Mott, Farmland Preservation Chairman, 335-1866 in the evenings. The next openings for applications will be in January or February of 2008. ## EMS

Report from Christiansburg Fire Department was the number of runs for the year was down. Only 17 from 32 in year 2005. There were 9 motor vehicles, 1 structure, 3 grass and 3 other full fires. This year there have been 2 fires. 1 run for EMS. They will be presenting a 5 year plan and outline capital improvements with upgrades to their building and equipment. Insurance and fuel have driven the cost up. They could use more manpower. Squad runs during the daytime hours are down. They are looking to go with paid daytime help and combine with Lostcreek and Jackson Townships.

In June there were 2 Medic runs. Illnesses and injuries were the cause. The average response time was 10 minutes

There were 6 Medic runs and 1 Fire run during the month of August, 2007. The average response time was 8 minutes from time of dispatch to time on scene.

The EMS has made 77 runs through the month of August.

The biggest issue we have is the speeding on State Route 41 and Alcony Conover Road. They are out here to protect us, so slow down.

## Voting at the Township House

Voting at the Township House is from 6:30 A.M. to 7:00 P.M. Make sure you have everything you need to vote. Be informed.

For the November 6, 2007 election, this is what is needed.

1. Proof of identity will be required at the polls. This could be current and valid photo ID, military ID, copy of utility bill, bank statement, pay check, government check or government document showing name and current address. Voters cannot use notice sent by Board of Elections.
2. Absentee voting no longer requires a reason to vote early. It is “no fault early voting.” Submit request for absentee ballot in writing to:

Include name, signature, address at which you are registered, date of birth, election you wish to vote, address ballot mailed to, and one of the following: drivers license number, last four digits of Social Security number, or copy of current/valid ID. Absentee voting must be received by Tuesday, November 6<sup>th</sup>.

3. Walk in voting at the Election Board, 201 W. Main Street, Troy is until Monday, November 5<sup>th</sup>, until 4:00 P.M.
