## **Zoning Board of Commission & Zoning Board of Appeals**

On May 25th the Miami County Zoning and Planning held a informational meeting at the Miami County Safety Building. There were several representatives from the Federal Emergency Management Agency (FEMA) to advise of the new FEMA maps on Flood Plain areas in Miami County. The Elizabeth Township Zoning Inspector was present and ascertained that there is a reduction of the amount of land that was designated in the Elizabeth Township Flood Plain. FEMA stated that the process would take 12-18 months to finalize maps and update all information. If your property was in the Flood Plain area, and after the updates it is not, then FEMA states that you will be able to cancel mandatory flood insurance on a mortgaged property and be able to go back 12 months for a refund from the insurance company. ## **Elizabeth Township Farmland Preservation**

We have four landowners in the Township who applied for the 2010 Ohio Agricultural Easement Protection Program consisting of a total of 654.37 acres. By virtue of their state application, they also qualified to apply for the 2010 USDA-NRCS FRPP program and have done so. This program had \$2.1 million in funds that were committed to farmland preservation in Ohio and our farms stand a very good chance of being accepted into this program. USDA-NRCS contributes 50% of the easement value, Elizabeth Township contributes 25% of the easement value, and the land owners donate the final portion of the value of the preservation easement. The deadline for the applications was June 16, 2010.

The Township Trustees have committed \$1,000,000 annually toward the preservation program. There have been preserved about 660 acres through the Ohio Agricultural Easement Protection Program, 680 acres through the USDA-FRPP program, and 640 acres through the local township program. We anticipate a new Ohio program will be

announced in early 2011, and we also believe that there will be another FRPP program in 2011. ## **Elizabeth Township Historical Museum**

Please let us hear your stories and if you or a family member don't feel comfortable writing them down call and a member of our society will help you. I hear people say they don't have anything of interest and then later I hear them discussing how things used to be. That is exactly what I believe needs to be written down for others to enjoy.

Don't forget to think of the museum when you are cleaning out the attic, garage, or barn. We are interested in anything that will show how the people of Elizabeth lived in the past. It doesn't have to be from 60-70 years ago. Things from 30 years ago are "old" to someone who is 10 years old.
