Expense Totals

General Fund \$1,071,930.52, Motor Vehicle License Tax \$8,865.50, Gasoline Tax \$234,483.50, Road and Bridge \$17,341.00, Permissive Motor Vehicle License Tax \$14,985.50, American Rescue Plan \$96,278.09, Shaggy Bark Lighting \$1,642.08, total expense \$1,445,526.19.

Mary Ann asked the board what amount would be needed in the budget to start the EMS/Fire services with Tipp City. The board felt \$500,000.00 would be sufficient to cover 2023 expenses. Mary Ann will include \$500,000.00 in the 2023 Permanent Budget for the expenses.

Mr. Mott-The hydraulic hose was leaking and 2 pins were missing from the mounting bracket on the snow plow. Mr. Mott shared a quote of \$57,000.00 from Beau Townsend Ford for a 2023 Ford F550 XL Gas V8 Pickup Cab and Chassis. Mr. Mott said the price included government discount. Mr. Mott also submitted a quote of \$40,084.00 from KE Rose for a stainless bed and accessories for the new truck. Mr. Mott said we have until January 13, 2023 to order it, if we want delivery in 2023. A Motion by Randy Mott, Seconded by John R. Ryman to accept the quote of \$57,000.00 from Beau Townsend Ford for the purchase of a 2023 Ford F550 XL V8 Gas cab and chassis as presented and accept the quote of \$40.084.00 from KE Rose for the stainless bed and accessories for the 2023 Ford Truck as presented. VOTE: Mr. Dilts-yes, Mr. Mott-yes, Mr. Rymanyes. John R. Ryman, President, declared the Motion carried. The current pickup will be sold through Govdeals.com when the new pickup is in service.

Mr. Ryman-Had no new business to discuss.

Mr. Dilts-Certification of highway miles will be held on February 1, 2023 at the county engineer's office beginning at 8:45 a.m.

ITEM # 9 Mary Ann contacted the Miami County Prosecutor's Office regarding Mr. Mott's request to add supplemental/gap insurance reimbursement for elected officials and full time employees. The prosecutor's office said supplemental/gap insurance reimbursement can be added, but wordage must be included in our current Resolution. The prosecutor's office will provide wordage for the additional supplemental/gap insurance reimbursement, for elected and full time employees. A Legal Opinion on the matter is to follow.
