Ryman to approve a \$.50 per hour raise to EMS/Fire employees deemed in good standing with participation within the schedule, by Adam Marchal. Making EMT/Fire \$20.00 per hour from \$19.50 and PM/Fire \$22.50 per hour from \$22.00. Along with implementing holiday pay for seven holidays throughout the year to include: New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, Christmas Eve and Christmas Day paying an hourly rate of one and one-half times the normal pay rate, effective with the payroll date of December 7, 2024. Paying of the increased holiday pay rate will cost the township approximately \$3,780.00 and the additional hourly pay increase will cost the township no more than \$8,760.00 annually.
